Ownership: Clinical Audit and Control Department

Applicability: This Policy shall apply to all Pharmacies or Health Facilities providing pharmaceutical services and subject to licensure under the Dubai Health Authority establishment law, which includes: General or Specialized Hospitals, Day Surgical Centres (DSC), Fertility Centres, and Outpatient facilities.

1. Purpose:

- 1.1. To align with the Dubai Health Authority (DHA) vision, mission and strategic objective, to direct resources to ensure healthy and safe environment for Dubai population.
- 1.2. To implement best practices, to improve efficacy, proper utilization and patient safety in regard to medicines and chemicals within all pharmacies in the Emirate Dubai.
- 1.3. To support the health sector demand in the Emirate of Dubai for Controlled (CD) and Semi-Controlled Drugs (SCD) medication shortage, and ensure availability of adequate stocks are maintained for patients' treatment and needs without interruptions.
- 1.4. Ensure safety and avoid emergency cases due to non-availability of CD and SCD medications.

2. <u>Scope:</u>

2.1. The process of transferring CD and SCD medications between health facilities/ pharmaceutical facilities.





3. Definitions and Abbreviations:

Authority: Dubai Health Authority.

Authorised suppliers: are registered with MOHAP as the agent for medicine / medicinal products or registered as a wholesaler with MOHAP.

Controlled Drug: is a medical and pharmaceutical products that contain any of the active substances in accordance with Federal Law No. (14) of 1995 in respect of of combating Narcotics and psychotropic substances and its amendments, and the lists of the International Narcotics Control Board (INCB) No. (1,2,3,4) contained in the United Nations Convention of 1971, which have a significant potential for abuse, addiction and/or illegal use.

Health Facility: Place permitted to provide health examinations for patients and help for diagnosis, treatment, nursing or admission for cure and recovery or any other related medical procedures relating to treatment or rehabilitation post treatment.

Narcotic Drugs: Every natural or synthetic substance that includes group of medical and pharmaceutical products that contain any of the active substances listed in International Narcotics Control Board (INCB) schedules Nos. (1,2,3,4) in accordance with the Single Convention on Narcotic Drugs of 1961 and as amended in the protocol of 1972, and Schedules mentioned in the Federal Law No. 14 of 1995 in respect of combating Narcotic drugs and Psychotropic substances and its amendments.

Pharmaceutical product: A medical product manufactured in a specific pharmaceutical form and has specific uses in humans or animals.

Pharmacy: A facility licensed to store, prepare, compound, dispense, display or sell medicinal products to the public directly, through a fixed or mobile facility, permanent or temporary.





Pharmacist: A person who holds a scientific qualification not less than a bachelor's degree in pharmacy or its equivalent from a higher institute, college or university recognized in the country, and who is licensed to practice the profession of pharmacy in the country in accordance with the provisions of Federal Law no. (8) of (2019) Concerning Medical products, Pharmacy profession and Pharmacies and its executive regulations.

Pharmacist in-charge: is the pharmacist licensed by DHA on a licensed pharmaceutical facility, and is responsible for implementing the provisions of Federal Law no. (8) of (2019) Concerning Medical products, Pharmacy profession and Pharmacies and its executive regulations within the scope of the tasks assigned to him.

Register: is a book issued from the concerned Health Authority (DHA or Ministry of Health and Prevention (MOHAP)) used by an authorized Healthcare Professionals at health facilities to record the transactions of Narcotics, CD and SCD medications within the pharmacy and inpatient units.

Semi Controlled Drugs: is a medical and pharmaceutical products not listed within the schedules attached to the Federal law No. 14 of 1995 in respect of combating of drugs and psychotropic substances and its amendments and not listed within the schedules attached to international conventions of the International Narcotics Control Board (INCB), and has medical benefits, but with long term use in high doses or use with other substances that might lead to habituation and addiction.

4. Policy Statement:

- 4.1. Transfer of Controlled Drugs (CD) and Semi-Controlled Drugs (SCD) between Pharmacies and other health facilities is prohibited and shall be considered an illegal practise resulting in disciplinary action. Conditions where transfer is permitted includes:
 - 4.1.1. Permanent or temporary closure of a health facility that is owned by the same owner.
 - 4.1.2. Non-availability and out of stock of CD or SCD medications through the authorized suppliers/agents in the UAE.
- 4.2. All transfers of CD and SCD must be authorised by the pharmacist in charge for both pharmacies and documented as per (**Appendix 1**).
 - 4.2.1. The transfer process will be accomplished within five (5) working days from date of submitting the application to the Health Regulation Sector (HRS) in Dubai Health Authority (DHA).
 - 4.2.2. The inspection team will visit the providing facility, and then they will visit the receiving facility to make sure that all the physical stock has been transferred along with the corresponding DHA registers.
- 4.3. All Health facilities are responsible to ensure availability of CD and SCD medications are managed through business continuity plans.
 - 4.3.1. Health facilities experiencing a persistent shortage of CD and SCD may seek a written approval issued by the authorized person in the HRS-DHA to to have in place an agreement with an authorized suppliers/distributer for the transfer of registered CD





and SCD for only emergencies to another facility for a different owner.

- 4.3.2. All requests to DHA/HRS must be submitted by written request which includes the justification for the reason of transfer. The request shall be sent to:

- 4.4. Narcotics shall not be transferred between health facilities and shall be considered an illegal supply and these results in legal accountability.
- 4.5. Any other transfer of CD and SCD would be considered as illegal supply, and may result in legal accountability.
- 4.6. The health facilities shall fill and submit to HRS (Drug Control Section) the CD and SCD Medication Transfer Request Form (Appendix 1).
- 4.7. Health inspectors are responsible to undertake facility audits add /deduct/ sign and document all transactions and new balance in the corresponding CD and SCD registers.
